# SPECIAL AGREEMENT ON COOPERATION

Faculty of Dentistry, Karadeniz Technical University, Kanuni Kampus, 61080 Trabzon, Turkey represented by Prof. Dr. Polat Koşucu, dean

**AND** 

Faculty of Dentistry, Ss. Cyril and Methodius University of Skopje, located on Majka Tereza St. 43, 1000 Skopje, the Republic of Macedonia, represented by PhD Kiro Ivanovski, Dean.

In accordance with General agreement on interuniversity cooperation signed on ......, 2018 between Faculty of Dentistry of the University of Karadeniz Technical University and Ss. Cyril and Methodius University of Skopje with strong will for further development of partners' relations, by defining clear program activities and stronger cooperation in the fields of teaching process, exchange of students, science, research, culture, as well as other fields of academic activities, all parties of agreement are concordant to fulfil these aims through this **Special agreement on cooperation (in further text: Special Agreement).** 

I

Special agreement has an aim to establish, namely to continue and improve scientific and teaching cooperation as well as cooperation in other fields of common activities.

II

Program activities are to be realised through the following:

- Mutual visits, students' journeys, teachers' and assistants' counselling due to mutual exchange of experience in teaching, scientific and research process;
- Exchange of students, teachers and their involvement in the realisation of scientific-teaching process at the first, second and third study cycles:
- Involvement in the work of committees for the aquirement of M.Sc. and PhD degrees as well as professional specialities in ceratin fields:
- Involvement in committees for the preparation of reports on the selection of teachers and associates;
- Mutual work on research projects;
- Enabling students to enrol at the second and third study courses and specialist studies in accordance with the general legal acts;
- Enabling realisation of scientific, master and PhD work of students at the second party of agreement;
- Visits of celebrations organised by one or the other party;
- Cooperation at scientific meetings, symposiums and conferences;

- Mutual exchange of publications (coursebooks, books, magazines, teaching materials, professional literature etc.);
- Encouragement of students' exchange during the first study cycle;
- Mutual exchange of scientific data;
- Other forms of interfaculty cooperation.

#### III

Exchange of teachers, associates and students, period of their stay, annual rates and other concrete forms of cooperation will be regulated by special working programs, and in the framework of the agreement determined by article II of this agreement.

#### IV

Working program will predict the list of projects and activities.

Every project and activity will have its name, holder and the way of realisation.

If it is needed for the realisation of project and its activities, Special agreement parties will sign special executive agreement.

Working programs will define rules referring to the rights of intellectual property and commercial use of research results.

## V

Agreement contractors will appoint their representatives and deputees for the realisation of cooperation determined by this Special agreement, and for the period of its validity. The task of the representative from the previous article is:

- Further development of interfaculty cooperation;
- Writing of the annual working program;
- Realisation of the established forms of cooperation between agreement contractors.
- Provision of financial means for the realisation of established forms of cooperation between agreement contractors.

Appointment of representatives for cooperation and their deputees will be delivered by dean in written form to other contractor, immediately after signing this Agreement.

#### VI

This Agreement is concluded for an indefinite period of time, but every contractor can cancel it even before determined deadline, with termination period of 3 months.

At the expiration of 5 years critical assessment of earlier cooperation will be carried out, and according to it the decision of further cooperation will be made.

## VII

All contigent arguments from or are in relation with Special agreement will be solved according to article IX of General agreement on interuniversity agreement.

# VIII

Special agreement is written and signed in 6 (six) same copies, of which 3 (three) are in Macedonian, and 3 (three) are in English.

All six copies of this agreement are regarded as authentic documents.

In accordance with above noted regulations, this document is signed and verified in 6 (six) same copies.
